To whom it may concern,

This is to confirm that international students starting their program in the 2024 Fall Term intake are enrolled in the Health and Dental insurance plan, should they meet the eligibility requirements, and have not voluntarily opted-out of the plan prior to the opt-out deadline. The plan is available to students enrolled at NorQuest College through their membership with the Students' Association of NorQuest College (SANQC). The plan provides Health & Dental coverage for eligible\* students for a 12 month period.

**\*Note: Non-credit programs are not included in this coverage**

This coverage will begin from the 1<sup>st</sup> day of the month in which their opt-out deadline occurs. The opt-out deadline is set for 14 days after each students' class start date. For example, students with a class start date of September 3<sup>rd</sup>, 2024 will have an opt-out deadline of September 17<sup>th</sup>, 2024 and will receive benefits starting September 1<sup>st</sup>, 2024. Students who are traveling before their start date, are encouraged to arrange a separate insurance plan for the period preceding the plan arranged by SANQC.
